Clay Tyree made a motion to approve the Statement of Assurance regarding the Teacher Evaluation System Status for FY 2019-2020, April Drane seconded. Motion passed 2-0. (Tyree-aye, Drane-aye)

3.2 Discussion of Administrative Rules and Regulations Regarding Certified and Support Staff -Bryan Bullington gave the Board a copy of the Administrative Rules and Regulations he had presented to the Certified Staff a few weeks earlier. He informed them that policy supersedes this document but it is a highlight of most common daily procedures and practices.

3.3 Discussion of December Budget Revision

-Bryan Bullington stated that we can revise our budget in December; our base support level has increased because of an increase in the number of students, we are under budget approximately \$1,000 in the M & O fund and our adjusted RCL in unrestricted capital is \$59,287. We can increase our budget by these amounts and it won't increase our tax rate this year. He is concerned because of the amount we have spent on repairs this school year and would like the cushion in case any other repairs are needed. Adjustments can be made in the next Budget year regarding tax rates and District priorities.

- -Septic and outside waterline replacement are complete. There is one more water issue having to do with the shut off valves and low flow in the old 6-8 classroom; we are looking into getting another estimate. There are still a couple trees that need to be removed but they do not cause any danger the way they are.
- -A new math (k-8) and science (6-8) curriculum was purchased called Edgenuity.
- -SFB grant issues will be looked into now that we are caught up with facilities issues.
